The Government of United Republic of Tanzania through Tanzania Forest Services Agency intends to sale standing teak trees by auction in felling couples with a total volume of 2,000.9 cubic meters of Teak Trees at Mtibwa Forest Plantation (Turiani - Morogoro) on Wednesday 25/07/2016 starting from 10.30 AM. The standing teak trees are sold as on “as is where is “basis and the selling entity shall have no further liability after sale.
2. Interested eligible firms/Individuals must provide information in an envelope on Monday 25/07/2016 by submitting copies of evidence of registration in trade of forest products and Tax Identification Number (TIN). Late comers to the auction ceremony will not be accepted.
3. Auction will be held publically and in the presence of all buyers at the plantation Manager’s office on Monday 25th July, 2016 and shall be conducted in accordance with the Forest Act Cap. 323.
4. Each felling couple/Plot will be auctioned separately basing on the price per cubic meter. **The highest price offered by the buyer at the auction shall not hinder other buyers to offer the highest price than that offered previously.**

5. Tanzania Forest Services (TFS) Agency now invites interested buyers to the auction at Mtibwa Forest Plantation. Firm/Individuals with enterprises for domestic wood processing and finished wood products are highly encouraged to participate in this auction.

6. Tanzania Forest Services (TFS) Agency will award the Letter of Offer to the highest buyer in each felling plot/couple.
7. The successful buyer shall not be allowed to export the logs as per regulation 50 (1) of the Forest Regulations of 2004. Exportation of forest products shall be in form of processed Timber as per Government Notice No. 69 of 2006.
8. Interested buyers may visit the site (felling plots/couples) at Mtibwa Forest Plantation from 09:00 hrs to 15:00 hrs Monday to Friday except on public holiday. The Plantation Manager or his assistant will provide additional information at the Plantation.
9. The interested buyer must collect and read harvesting conditions for each plantation

10. Minimum base price for one (1) cubic meter is **TZS 500,000** (FIVE HUNDRED THOUSANDS ONLY) VAT, CESS and LMDA inclusive.

11. The successful buyer shall pay 25% of the total value which is non-refundable upon any default three days (3) after the auction ceremony and the remaining 75% shall be paid within 14 days.
