2. The **Tanzania Forest Service (TFS) Agency** now invites sealed Tenders from eligible contractors registered or capable of being registered in class four (IV) and above shall carrying out the **Construction of two offices block for Mbeya and Masasi as described on table below.**

The bidder shall submit Bank pay - in - slip as evidence of the deposited amount.
