It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the **Construction of building blocks at Sao-Hill Forest plantation at Mafinga- Iringa.**
2. The **Tanzania Forest Service (TFS) Agency** now invites sealed Tenders from eligible contractors registered or capable of being registered in class four (IV) and above shall carry out the **Construction of building blocks at Sao-Hill Forest plantation at Mafinga- Iringa.**
3. Bidder may quote for one lot or more lots but each lot should be quoted separately.

The bidder shall submit Bank pay - in - slip as evidence of the deposited amount.
7. All Tenders must be accompanied by a Tender securing declaration in the format provided in the Tendering documents unless otherwise stated in the Tender Data Sheet.
8. All Tenders in one original plus **two copies** properly filled in, and enclosed in plain envelopes must be delivered to the address P.O BOX 40832, Room no. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the Conference room of Tanzania Forest Services Agency 3rd floor.
9. Late Tenders portion of Tenders, electronic Tenders, Tenders not received, Tenders not opened at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
